Summary: This circular contains the names of the Officials appointed for the 2021 Masters & Opens Australian Surf Life Saving Championships, together with all relevant reporting, briefing and other matters for notation by appointed Officials.

This document has been prepared with the best intentions based on current State Health Authority information regarding COVID-19 restrictions and related border movements. However, as has been noted over many months this information is constantly changing and as such all officials should be prepared to allow for some flexibility in their planning.
